#### USTA League Reminders and Regulations

- In lieu of skip week pushed out start date work together now to reschedule for any conflicts that may occur later in the season
- Other than the first week of season any rescheduling at all needs to be played before the regularly scheduled match date
- Full Team Defaults
  - o Must play a majority of lines for a match to be valid
    - 3-line matches must play at least two lines
    - 4 and 5-line matches must play at least three lines
  - o If a team defaults two or more full team matches a grievance will be filed against the entire team
  - O Remind your players when you register are making a commitment to play
- Scorecard Corrections
  - Captains/players are strongly advised to confirm scores and player names with one another at the conclusion of the match to avoid confusion with incorrect scorecard entry.
  - Captains have until 2 weeks from the time match scores have been entered to request a correction to a scorecard. After that time, unless a scorecard exchange can be produced (via attachment in email or photos of scorecard) with both line-ups entered (done at time of match) no requests towards changes can be made.
  - o Captains must complete the <u>Scorecard Correction Form</u> to request scorecard changes.

    - 0 Local play; 1 Singles and <u>3</u> Doubles
    - o State championship and beyond: 1 line of singles and <u>4</u> doubles

- All National Championship advancing Mixed League divisions will enforce the NTRP Dynamic Disqualification procedures in accordance with the USTA League Regulation 2.04.
- O The process in which a NTRP Dynamic Disqualification occurs in the Mixed 18 & Over and Mixed 40 & Over National Championship Advancing League Divisions is the same as the current process in the Adult Leagues that advance to the Championships. However, strikes earned in mixed doubles, will not be combined with strikes earned in Adult Leagues, it will be a separate.
- NTRP Dynamic Disqualifications in the specified Mixed Divisions will support fairer playing levels. This will keep the integrity of the USTA League Program intact so everyone will be playing at a similar playing level.
